Games Description

Station 1 - Noodle Tap

Ages: 6yrs & Under (Legs Only), 8yrs & Under (Legs & Body Only) and 10yrs & Under (Legs, Body & Head - Helmet Required)

Duration: 1 Minute Bouts

Objective: Each player is equipped with a soft noddle. Points are awarded for striking at specific areas of the body. The player with the most points at the end of time is declared the winner. Blocking is permitted.

Goal: Develop footwork, defence, agility and speed.

Station 2 - Gladiator

Ages: 6yrs & Under, 8yrs & Under and 10yrs & Under

Duration: 1 Minute Bouts

Objective: Each player is equipped with body shields; the aim of the game is to force your opponent out of the ring using your body shield as part of your body. The only point of contact is the body shields. Players have unlimited opportunities to force their opponent out of the ring within the specified timeframe.

Goal: Develop footwork, balance, power and speed.

Station 3 - Hit Out

Ages: 6yrs & Under, 8yrs & Under and 10yrs & Under

Duration: 30 Second Bouts

Objective: Each player displays a range of kicking, punching and striking combinations on a free standing bag. Points are awarded for technique and variation. Note, 6yrs & Under will demonstrate on Body Shields.

Goal: Develop footwork, distance, power and speed.

CONDITIONS

1. In these conditions: "the Company" shall mean and include Karate West Pty Ltd. Its officers, servants or agents. "Opponents" shall mean any person competing against the competitor.
2. In consideration of the Company accepting my application to enter and compete in the tournament an in further consideration of my opponent competing against me, I hereby agree to abide by the conditions of entry, the rules, by-laws and regulations of the Company.

6. I acknowledge and agree that my opponent shall not be liable whether in tort or contract or otherwise for any loss or damage or injury whatsoever to my person or property whilst participating in or otherwise attending at the tournament, howsoever caused by or occurring including without limiting the foregoing, the negligence, breach of contract, willful act or default of my opponent and whether or not such loss or damage or injury to me occurs within or adjacent to my property occupied by the Company.
7. I authorise the Company to contract on my behalf to exclude my liability as an opponent whether such arises in tort or contract or otherwise for any loss or damage or injury to another competitor however caused or occurring including but without limiting the foregoing, the negligence, breach of contract, willful act or default of myself.
8. I expressly agree to and do hereby waive any rights that I may have which are in any way inconsistent with the foregoing.
9. Age is determined by the age of the competitor on 08.09.13.
10. If under 18 years of age entry forms must be signed by a parent/guardian.
11. All competitors must have current insurance.
12. The following safety equipment is COMPULSORY for Station 1 & 2 - Helmet or mask for Under 10yrs and Station 3 - Gloves for all ages.

Disclaimer

2. I hereby acknowledge that my entry and/or participation in the Tournament carries with it significant risk of personal injury.
